INVASIVE SPECIES MITIGATION PROJECTS.

FIRST: QBC HAS BEEN REMOVING, AND WILL CONTINUE TO REMOVE, TRASH AT THE SURFACE BY
BOAT, AND TRASH AND DEBRIS BELOW THE SURFACE BY SCUBA DIVERS. THIS WILL IMPROVE THE
WATER QUALITY IN THIS AREA.

SECOND: QBC MAINTAINS AND OPERATES A SEPTIC PUMP OUT BOAT, WHICH PROVIDES A FREE
SERVICE FOR TRAVELING BOAT CRUISERS, GIVING THEM THE OPPORTUNITY TO HAVE THEIR SEPTIC

WILL ENGAGE IN A SOFT SHELL CLAM REINTRODUCTION PROJECT.
